CHAPTER 169

SENATE BILL 1376

AN ACT

AMENDING TITLE 36, CHAPTER 5.1, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 36-567; RELATING TO DEVELOPMENTAL DISABILITIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 5.1, article 1, Arizona Revised Statutes,
3 is amended by adding section 36-567, to read:

4 36-567. Music therapists; minimum qualifications; definition

5 A. THE DIVISION SHALL REQUIRE QUALIFICATIONS FOR PERSONS WHO PROVIDE
6 MUSIC THERAPY SERVICES THROUGH A CONTRACT TO PERSONS WITH DEVELOPMENTAL
7 DISABILITIES. AT A MINIMUM THESE QUALIFICATIONS SHALL REQUIRE CURRENT
8 CERTIFICATION BY A NATIONAL CERTIFICATION BOARD FOR MUSIC THERAPISTS. THE
9 DIVISION SHALL IDENTIFY THE SERVICES PROVIDED BY MUSIC THERAPISTS WHO MEET
10 THESE QUALIFICATIONS AS MUSIC THERAPY.

11 B. FOR THE PURPOSES OF THIS SECTION, "MUSIC THERAPY" MEANS IMPLEMENTING
12 HABILITATION GOALS THROUGH CLINICAL AND EVIDENCE-BASED MUSIC THERAPY
13 INTERVENTIONS TO ACCOMPLISH INDIVIDUALIZED GOALS AND THE SERVICES THAT ARE
14 CONSISTENT WITH THE OVERALL INDIVIDUAL PROGRAM PLAN ESTABLISHED BY THE
15 PLANNING TEAM.
