10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the board of library examiners to pass on the
13 qualifications of persons desiring to become county librarians.
14 Sec. 4. Retroactivity
15 Sections 1 and 2 of this act are effective retroactively to July 1,
16 2010.
