HOUSE BILL 2051

AN ACT

AMENDING TITLE 40, CHAPTER 2, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 40-210; RELATING TO REGULATION BY THE CORPORATION COMMISSION.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 40, chapter 2, article 1, Arizona Revised Statutes,
3 is amended by adding section 40-210, to read:
4 40-210. Contractors; requirements; prohibition; definition
5 A. A CONTRACTOR WHO IS LICENSED BY THE REGISTRAR OF CONTRACTORS
6 PURSUANT TO TITLE 32 IS ELIGIBLE TO PARTICIPATE IN A COMMISSION APPROVED
7 REBATE OR OTHER PRICING PROGRAM OFFERED BY A PUBLIC SERVICE CORPORATION IF
8 THE CONTRACTOR OBTAINS THE SAME OR EQUIVALENT TRAINING OR CERTIFICATION
9 REQUIRED UNDER THE PROGRAM.
10 B. A CONTRACTOR WHO IS LICENSED UNDER THE REGISTRAR OF CONTRACTORS
11 PURSUANT TO TITLE 32 SHALL NOT BE REQUIRED TO:
12 1. JOIN ANY TRADE ASSOCIATION OR OTHER MEMBERSHIP ORGANIZATION.
13 2. PAY DUES TO ANY TRADE ASSOCIATION OR OTHER MEMBERSHIP ORGANIZATION.
14 C. FOR THE PURPOSES OF THIS SECTION, "CONTRACTOR" HAS THE SAME MEANING
15 PRESCRIBED IN SECTION 32-1101.
