HOUSE BILL 2224

AN ACT

AMENDING TITLE 8, CHAPTER 5, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 8-530; RELATING TO CHILD WELFARE AND PLACEMENT.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 8, chapter 5, article 1, Arizona Revised Statutes, is
3 amended by adding section 8-530, to read:
4 8-530. Foster parents; rights
5 A. A FOSTER PARENT IN THIS STATE HAS THE FOLLOWING RIGHTS:
6 1. TO BE TREATED WITH CONSIDERATION AND RESPECT FOR THE FOSTER
7 PARENT'S PERSONAL DIGNITY AND PRIVACY.
8 2. TO BE INCLUDED AS A VALUED MEMBER OF THE TEAM THAT PROVIDES
9 SERVICES TO THE FOSTER CHILD.
10 3. TO RECEIVE SUPPORT SERVICES THAT ASSIST THE FOSTER PARENT TO CARE
11 FOR THE CHILD IN THE FOSTER HOME, INCLUDING OPEN AND TIMELY RESPONSES FROM
12 AGENCY PERSONNEL.
13 4. TO BE INFORMED OF ALL INFORMATION REGARDING THE CHILD THAT WILL
14 IMPACT THE FOSTER HOME OR FAMILY LIFE DURING THE CARE OF THE FOSTER CHILD.
15 5. TO CONTRIBUTE TO THE PERMANENCY PLAN FOR THE CHILD IN THE FOSTER
16 HOME.
17 6. TO HAVE PLACEMENT INFORMATION KEPT CONFIDENTIAL WHEN IT IS
18 NECESSARY TO PROTECT THE FOSTER PARENT AND THE MEMBERS OF THE FOSTER PARENT'S
19 HOUSEHOLD.
20 7. TO BE ASSISTED IN DEALING WITH FAMILY LOSS AND SEPARATION WHEN A
21 CHILD LEAVES THE FOSTER HOME.
22 8. TO BE INFORMED OF ALL AGENCY POLICIES AND PROCEDURES THAT RELATE TO
23 THE FOSTER PARENT'S ROLE AS A FOSTER PARENT.
24 9. TO RECEIVE TRAINING THAT WILL ENHANCE THE FOSTER PARENT'S SKILLS
25 AND ABILITY TO COPE AS A FOSTER PARENT.
26 10. TO BE ABLE TO RECEIVE SERVICES AND REACH PERSONNEL ON A TWENTY-FOUR
27 HOUR, SEVEN DAYS PER WEEK BASIS.
28 11. TO BE GRANTED A REASONABLE PLAN FOR RESPITE FROM THE ROLE OF FOSTER
29 PARENT.
30 12. TO CONFIDENTIALITY REGARDING ISSUES THAT ARISE IN THE FOSTER HOME.
31 13. TO NOT BE DISCRIMINATED AGAINST ON THE BASIS OF RELIGION, RACE,
32 COLOR, CREED, SEX, NATIONAL ORIGIN, AGE OR PHYSICAL HANDICAP.
33 14. TO RECEIVE AN EVALUATION ON THE FOSTER PARENT'S PERFORMANCE.
34 B. THIS SECTION DOES NOT ESTABLISH ANY LEGALLY ENFORCEABLE RIGHT OR
35 CAUSE OF ACTION ON BEHALF OF ANY PERSON.
