AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-500.30; AMENDING TITLE 11, CHAPTER 2, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-251.14; AMENDING TITLE 41, ARIZONA REVISED STATUTES, BY ADDING CHAPTER 48; RELATING TO FEDERAL MONIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes, is
3 amended by adding section 9-500.30, to read:

5 A CITY OR TOWN IS PROHIBITED FROM ACCEPTING FEDERAL MONIES FOR A
6 CONSTRUCTION PROJECT IF AS A CONDITION OF ACCEPTING THE FEDERAL MONIES THE
7 CITY OR TOWN IS REQUIRED TO GIVE A PREFERENCE TO UNION LABOR.

8 Sec. 2. Title 11, chapter 2, article 4, Arizona Revised Statutes, is
9 amended by adding section 11-251.14, to read:

10 11-251.14. Federal monies; prohibition; union labor preference

11 A BOARD OF SUPERVISORS IS PROHIBITED FROM ACCEPTING FEDERAL MONIES FOR
12 A CONSTRUCTION PROJECT IF AS A CONDITION OF ACCEPTING THE FEDERAL MONIES THE

22 ACCEPTING THE FEDERAL MONIES THE DEPARTMENT, INSTITUTION, BOARD OR COMMISSION
23 IS REQUIRED TO GIVE A PREFERENCE TO UNION LABOR.
