SENATE BILL 1153

AN ACT

AMENDING TITLE 9, CHAPTER 3, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-305; RELATING TO CITY AND TOWN OFFICERS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 3, article 1, Arizona Revised Statutes, is
3 amended by adding section 9-305, to read:

4 9-305. City or town auditor; examination of executive session
5 minutes; confidential information

6 A. IF A CITY OR TOWN HAS ESTABLISHED THE OFFICE OF CITY OR TOWN
7 AUDITOR, THE CITY OR TOWN, BY ORDINANCE, MAY PROVIDE THAT THE CITY OR TOWN
8 AUDITOR OR THE AUDITOR'S AUTHORIZED REPRESENTATIVE, IN THE PERFORMANCE OF
9 THEIR OFFICIAL DUTIES, EXAMINE THE MINUTES OF EXECUTIVE SESSIONS OF THE CITY
10 OR TOWN COUNCIL OR ANY BOARD, COMMISSION OR OTHER PUBLIC BODY ESTABLISHED BY
11 THE CITY OR TOWN.

12 B. WORKING PAPERS AND OTHER AUDIT FILES THAT ARE MAINTAINED BY THE
13 CITY OR TOWN AUDITOR ARE NOT PUBLIC RECORDS AND ARE EXEMPT FROM TITLE 39,
14 CHAPTER 1. ANY AUDIT REPORT PREPARED FOR OR PRESENTED TO A CITY OR TOWN,
15 WHETHER BY CITY OR TOWN AUDITOR, THE AUDITOR'S AUTHORIZED REPRESENTATIVE OR A
16 CONSULTANT, IS A PUBLIC RECORD SUBJECT TO TITLE 39, CHAPTER 1.
