CHAPTER 107

HOUSE BILL 2851

AN ACT

PROVIDING FOR THE APPOINTMENT OF THE OMBUDSMAN-CITIZENS AIDE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appointment of ombudsman-citizens aide

3 Pursuant to section 41-1373, subsection B, Arizona Revised Statutes,
4 Dennis Wells is appointed ombudsman-citizens aide for a term ending from and
5 after June 30, 2017, subject to the terms and conditions prescribed by law.

6 Sec. 2. Requirements for appointment

7 Pursuant to section 41-1373, subsection B, Arizona Revised Statutes,
8 this act requires approval of the appointment by roll call vote of at least
9 two-thirds of the membership of each house of the legislature and the
10 approval of the governor or, if the governor vetoes this act, this act
11 requires the subsequent approval of the appointment by roll call vote of at
12 least three-fourths of the membership of each house of the legislature.

13 Sec. 3. Emergency

14 This act is an emergency measure that is necessary to preserve the
15 public peace, health or safety and is operative immediately as provided by
16 law.
