HOUSE BILL 2446

AN ACT

AMENDING TITLE 12, CHAPTER 6, ARTICLE 12, ARIZONA REVISED STATUTES, BY ADDING SECTION 12-718; RELATING TO CIVIL ACTIONS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 12, chapter 6, article 12, Arizona Revised Statutes,
3 is amended by adding section 12-718, to read:
4 12-718. Emergency aid involving liquefied petroleum gas;
5 exemption from civil liability
6 A. A PERSON WHO HAS KNOWLEDGE AND TRAINING IN THE STORAGE, HANDLING,
7 TRANSPORTATION, OPERATION AND UTILIZATION OF LIQUEFIED PETROLEUM GAS IS NOT
8 LIABLE IN ANY CIVIL ACTION FOR ANY DAMAGES THAT OCCUR AS A RESULT OF
9 PROVIDING ASSISTANCE WITHOUT REMUNERATION, ON THE REQUEST OF ANY PEACE
10 OFFICER, FIRE COMPANY OR DEPARTMENT, FIRST AID, RESCUE OR EMERGENCY SQUAD OR
11 OTHER GOVERNMENTAL AGENCY OR ENTITY, IN AN ACCIDENT OR OTHER EMERGENCY
12 SITUATION THAT INVOLVES THE USE, HANDLING, TRANSPORTATION, TRANSMISSION OR
13 STORAGE OF LIQUEFIED PETROLEUM GAS IF THE PERSON WAS CONSCRIPTED AT THE SCENE
14 AS A TRUE VOLUNTEER.
15 B. THIS SECTION DOES NOT APPLY TO A PERSON WHO CAUSES THE ACCIDENT OR
16 EMERGENCY SITUATION OR WHOSE WILFUL, WANTON OR GROSSLY NEGLIGENT ACT OR
17 OMISSION IN RESPONSE TO THE ACCIDENT OR EMERGENCY SITUATION CAUSES DAMAGE OR
18 FOR ANY VICARIOUS LIABILITY.
