HOUSE BILL 2449

AN ACT

AMENDING SECTION 12-119.03, ARIZONA REVISED STATUTES; RELATING TO THE SUPREME COURT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 12-119.03, Arizona Revised Statutes, is amended to
3 read:

4 12-119.03. Performance audit; supreme court administration and
5 programs; hearing

6 The auditor general shall conduct a performance audit, as defined in
7 section 41-1278, of the administrative office of the courts at the request of
8 the joint legislative audit committee that is established pursuant to section
9 41-1279. The auditor general shall limit the performance audit to the
10 administration and operation of the supreme court and to those programs and
11 funds that are administered by the supreme court. The auditor general shall
12 submit copies of the performance audit to the president of the senate, the
13 speaker of the house of representatives and the chairpersons of the senate
14 judiciary committee and the house of representatives judiciary committee, or
15 their successor committees. THE SENATE AND HOUSE OF REPRESENTATIVES
16 JUDICIARY COMMITTEES SHALL MEET JOINTLY AND HOLD A HEARING ON THE AUDIT.
