HOUSE BILL 2803

AN ACT

AMENDING SECTION 42-19051, ARIZONA REVISED STATUTES; RELATING TO PERSONAL
PROPERTY TAX APPEALS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 42-19051, Arizona Revised Statutes, is amended to
3 read:
4 42-19051. Administrative review of valuation or classification
5 by assessor
6 A. The owner of property that is valued by the assessor or the person
7 in whose possession it is found may appeal to the assessor within ~~twenty~~
8 THIRTY days after the date the notice was delivered by filing a petition with
9 the assessor on a form prescribed by the department. The petition shall set
10 forth in writing:
11 1. The owner's opinion of the value or legal classification of the
12 property.
13 2. Substantial information that justifies the opinion of value or
14 legal classification in order for the assessor to consider the information
15 for the purpose of basing a change in the valuation or legal classification.
16 B. The assessor shall rule on each petition within twenty days after
17 it is filed.
18 C. The notice provided under this section shall be in the same manner
19 as prescribed in section 42-16056.
20 D. If the request of the petitioner is denied, in whole or in part,
21 the assessor shall deliver to the petitioner written notice of the grounds
22 for refusing to grant the request contained in the petition.
