# **HOUSE BILL 2567**

AN ACT

AMENDING TITLE 35, CHAPTER 1, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 35-125; RELATING TO BUDGET PREPARATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 35, chapter 1, article 2, Arizona Revised Statutes,  
3 is amended by adding section 35-125, to read:

4 35-125. Revenue and expenditure estimates; three-year plan;  
5 public hearing

6 THE GENERAL APPROPRIATION ACT SHALL INCLUDE A PROVISION THAT DELINEATES  
7 THE REVENUE AND EXPENDITURE ESTIMATES FOR THE FOLLOWING THREE YEARS. THE  
8 EXPENDITURE ESTIMATES SHALL BE BASED ON EXISTING STATUTORY FUNDING  
9 REQUIREMENTS. BEFORE THE ADOPTION OF THE GENERAL APPROPRIATION ACT, THE  
10 LEGISLATURE SHALL DISCUSS THE ESTIMATES IN A PUBLIC HEARING.
