AN ACT

REPEALING SECTION 41-3012.21, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3022.21; RELATING TO THE DEPARTMENT OF JUVENILE CORRECTIONS.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Repeal  
3 Section 41-3012.21, Arizona Revised Statutes, is repealed.  
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3022.21, to read:  
6 41-3022.21. Department of juvenile corrections; termination  
7 July 1, 2022  
8 A. THE DEPARTMENT OF JUVENILE CORRECTIONS TERMINATES ON JULY 1, 2022.  
9 B. TITLE 41, CHAPTER 26 IS REPEALED ON JANUARY 1, 2023.  
10 Sec. 3. Purpose  
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
12 the legislature continues the department of juvenile corrections to provide  
13 supervisory staff and administrative functions at the state level for all  
14 matters relating to the institutionalization, rehabilitation, education and  
15 release of all juvenile offenders.  
16 Sec. 4. Retroactivity  
17 Sections 1 and 2 of this act are effective retroactively to July 1,  
18 2012.
