1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Apache county attorney; legal action; habitat
3 destruction

4 Monies appropriated to the department of administration for
5 distribution to the Apache county attorney's office shall be used to
6 represent the interests of the people of Arizona and Apache county for legal
7 action against the United States forest service for the destruction of
8 endangered species habitat in Arizona caused by the lack of forest thinning
9 and forage fuel removal activities.
