HOUSE BILL 2011

AN ACT

AMENDING SECTION 36-1624.01, ARIZONA REVISED STATUTES; RELATING TO GAS APPLIANCES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 36-1624.01, Arizona Revised Statutes, is amended to
3 read:

4 36-1624.01. Liquefied petroleum gas container; filling;
5 evacuating; requirements; violation;
6 classification

7 A. A person, other than the owner of a liquefied petroleum gas
8 container or a person authorized in writing by the owner, shall not:

9 1. Fill or refill a liquefied petroleum gas container with liquefied
10 petroleum gas or any other gas or compound.

11 2. Evacuate a liquefied petroleum gas container.

12 3. Deface, erase, obliterate, cover up or otherwise remove or conceal
13 any name, mark, initial or device on a liquefied petroleum gas container.

14 B. This section does not apply to cylinders.

15 C. Notwithstanding section 36-1626, a person who violates this section
16 is guilty of a ~~petty offense~~ CLASS 3 MISDEMEANOR.


