# **HOUSE BILL 2097**

AN ACT

AMENDING TITLE 13, CHAPTER 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 13-814; RELATING TO PAWNBROKERS AND DEALERS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 13, chapter 8, Arizona Revised Statutes, is amended  
3 by adding section 13-814, to read:

4 13-814. Restitution to pawnbrokers and dealers; definitions

5 A. IF THE LAWFUL OWNER OF STOLEN PROPERTY RECOVERS THE PROPERTY FROM A  
6 PAWNBROKER OR DEALER AND THE PERSON WHO SOLD OR PLEDGED THE PROPERTY TO THE  
7 PAWNBROKER OR DEALER IS CONVICTED OF A VIOLATION OF LAW THAT IS RELATED TO  
8 THE STOLEN OR PLEDGED PROPERTY, THE COURT SHALL ORDER THE DEFENDANT TO MAKE  
9 RESTITUTION TO THE PAWNBROKER PURSUANT TO THIS CHAPTER.

10 B. FOR THE PURPOSES OF THIS SECTION:

11 1. "DEALER" HAS THE SAME MEANING PRESCRIBED IN SECTION 44-1601.

12 2. "PRECIOUS ITEM" HAS THE SAME MEANING PRESCRIBED IN SECTION 44-1601.

13 3. "PROPERTY" INCLUDES A NUMISMATIC OR BULLION GOLD COIN AND A  
14 PRECIOUS ITEM.
