AN ACT

REPEALING SECTION 41-3013.04, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3023.04; RELATING TO THE ARIZONA GRAIN RESEARCH AND PROMOTION COUNCIL.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3013.04, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3023.04, to read:

6 41-3023.04. Arizona grain research and promotion council;
7 termination July 1, 2023

8 A. THE ARIZONA GRAIN RESEARCH AND PROMOTION COUNCIL TERMINATES ON JULY
9 1, 2023.

10 B. TITLE 3, CHAPTER 3, ARTICLE 9 IS REPEALED ON JANUARY 1, 2024.

11 Sec. 3. Purpose

12 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
13 the legislature continues the Arizona grain research and promotion council to
14 assist the development of the grain industry in this state.

15 Sec. 4. Retroactivity

16 Sections 1 and 2 of this act are effective retroactively to July 1,
17 2013.
