# **SENATE BILL 1337**

AN ACT

AMENDING TITLE 15, CHAPTER 7, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 15-718.01; RELATING TO SCHOOL CURRICULUM.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 15, chapter 7, article 1, Arizona Revised Statutes,  
3 is amended by adding section 15-718.01, to read:

4 15-718.01. Instruction on cardiopulmonary resuscitation;  
5 exemptions; definition

6 A. SCHOOL DISTRICTS AND CHARTER SCHOOLS MAY PROVIDE PUBLIC SCHOOL  
7 PUPILS WITH ONE OR MORE TRAINING SESSIONS IN CARDIOPULMONARY RESUSCITATION,  
8 THROUGH THE USE OF PSYCHOMOTOR SKILLS IN AN AGE-APPROPRIATE MANNER, DURING  
9 THE SEVENTH, EIGHTH, NINTH, TENTH, ELEVENTH OR TWELFTH GRADE.

10 B. IF A SCHOOL DISTRICT OR CHARTER SCHOOL PROVIDES TRAINING PURSUANT  
11 TO THIS SECTION, THE TRAINING SHALL BE BASED ON THE MOST CURRENT TRAINING  
12 DEVELOPED BY A NATIONALLY RECOGNIZED NONPROFIT ORGANIZATION THAT PROVIDES  
13 TRAINING IN CARDIOPULMONARY RESUSCITATION THAT IS BASED ON THE MOST CURRENT  
14 NATIONAL EVIDENCE-BASED EMERGENCY CARDIOVASCULAR CARE GUIDELINES FOR  
15 CARDIOPULMONARY RESUSCITATION.

16 C. IF A SCHOOL DISTRICT OR CHARTER SCHOOL OFFERS INSTRUCTION THAT  
17 RESULTS IN CARDIOPULMONARY RESUSCITATION CERTIFICATION, THE INSTRUCTION MUST  
18 BE PROVIDED BY A CERTIFIED CARDIOPULMONARY RESUSCITATION TRAINER. THIS  
19 SUBSECTION DOES NOT REQUIRE A TEACHER OR ADMINISTRATOR WHO FACILITATES,  
20 PROVIDES OR OVERSEES THE INSTRUCTION TO BE AN AUTHORIZED TRAINER OF  
21 CARDIOPULMONARY RESUSCITATION IF THE INSTRUCTION DOES NOT RESULT IN  
22 CARDIOPULMONARY RESUSCITATION CERTIFICATION.

23 D. IF A SCHOOL DISTRICT OR CHARTER SCHOOL PROVIDES TRAINING PURSUANT  
24 TO THIS SECTION, A PUPIL SHALL BE EXCUSED FROM THE INSTRUCTION ON  
25 CARDIOPULMONARY RESUSCITATION AT THE REQUEST OF EITHER:

26 1. THE PUPIL'S PARENT.

27 2. A PUPIL WHO PROVIDES WRITTEN DOCUMENTATION THAT THE PUPIL HAS  
28 PREVIOUSLY RECEIVED TRAINING IN OR IS CURRENTLY CERTIFIED IN CARDIOPULMONARY  
29 RESUSCITATION.

30 E. IF A SCHOOL DISTRICT OR CHARTER SCHOOL PROVIDES TRAINING PURSUANT  
31 TO THIS SECTION, A SCHOOL DISTRICT OR CHARTER SCHOOL MAY ACCEPT FROM ANY  
32 PERSON, PUBLIC ENTITY OR OTHER LEGAL ENTITY IN-KIND DONATIONS OF MATERIALS,  
33 EQUIPMENT OR SERVICES THAT MAY BE USED IN THE INSTRUCTION ON CARDIOPULMONARY  
34 RESUSCITATION.

35 F. FOR THE PURPOSES OF THIS SECTION, "PSYCHOMOTOR SKILLS" MEANS  
36 SEQUENCES OF PHYSICAL ACTIONS THAT ARE PRACTICED IN A MANNER THAT SUPPORTS  
37 COGNITIVE LEARNING.
