SENATE BILL 1292

AN ACT

AMENDING TITLE 37, CHAPTER 2, ARIZONA REVISED STATUTES, BY ADDING ARTICLE 20;
AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING
SECTION 41-3024.01; RELATING TO THE ARIZONA RESOURCE ADVISORY COUNCIL.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 37, chapter 2, Arizona Revised Statutes, is amended
3 by adding article 20, to read:

4 ARTICLE 20. ARIZONA RESOURCE ADVISORY COUNCIL

5 37-620.31. Arizona resource advisory council; membership;
6 duties; report

7 A. THE ARIZONA RESOURCE ADVISORY COUNCIL IS ESTABLISHED CONSISTING OF
8 THE FOLLOWING MEMBERS:

9 1. THREE PERSONS WHO ARE APPOINTED BY THE GOVERNOR, ONE OF WHOM IS A
10 MEMBER OF THE FEDERAL RESOURCE ADVISORY COUNCIL AND WHO EITHER:

11 (a) REPRESENTS INTERESTS ASSOCIATED WITH TRANSPORTATION OR
12 RIGHTS-OF-WAY.

13 (b) REPRESENTS THE COMMERCIAL TIMBER INDUSTRY.

14 (c) REPRESENTS THE MINERAL OR ENERGY DEVELOPMENT INDUSTRY.

15 2. ONE PERSON WHO IS APPOINTED BY THE GOVERNOR AND WHO EITHER:

16 (a) REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED ENVIRONMENTAL OR
17 CONSERVATION ORGANIZATION.

18 (b) REPRESENTS DISPERSED RECREATIONAL ACTIVITY INTERESTS.

19 (c) REPRESENTS ARCHAEOLOGICAL OR HISTORICAL INTERESTS.

20 (d) REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED WILD HORSE AND
21 BURRO INTEREST GROUP.

22 3. A PERSON WHO IS EMPLOYED BY THE STATE LAND DEPARTMENT OR THE
23 DEPARTMENT OF WATER RESOURCES AND WHO IS APPOINTED BY THE GOVERNOR.

24 4. ONE PERSON WHO IS APPOINTED BY THE PRESIDENT OF THE SENATE AND WHO
25 EITHER:

26 (a) REPRESENTS INTERESTS ASSOCIATED WITH TRANSPORTATION OR
27 RIGHTS-OF-WAY.

28 (b) REPRESENTS THE COMMERCIAL TIMBER INDUSTRY.

29 (c) REPRESENTS THE MINERAL OR ENERGY DEVELOPMENT INDUSTRY.

30 5. ONE PERSON WHO IS APPOINTED BY THE PRESIDENT OF THE SENATE AND WHO
31 EITHER:

32 (a) REPRESENTS DISPERSED RECREATIONAL ACTIVITY INTERESTS.

33 (b) REPRESENTS ARCHAEOLOGICAL OR HISTORICAL INTERESTS.

34 (c) REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED WILD HORSE AND
35 BURRO INTEREST GROUP.

36 6. ONE PERSON WHO REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED
37 ENVIRONMENTAL OR CONSERVATION ORGANIZATION AND WHO IS APPOINTED BY THE
38 PRESIDENT OF THE SENATE.

39 7. ONE PERSON WHO HOLDS STATE, COUNTY OR LOCAL ELECTED OFFICE AND WHO
40 IS APPOINTED BY THE PRESIDENT OF THE SENATE.

41 8. ONE PERSON WHO IS A PROFESSOR AT A UNIVERSITY IN THIS STATE, WHO
42 SPECIALIZES IN NATURAL RESOURCE MANAGEMENT OR NATURAL SCIENCES AND WHO IS
43 APPOINTED BY THE PRESIDENT OF THE SENATE.

44 9. ONE PERSON WHO IS APPOINTED BY THE SPEAKER OF THE HOUSE OF
45 REPRESENTATIVES AND WHO EITHER:

1 (a) REPRESENTS INTERESTS ASSOCIATED WITH TRANSPORTATION OR
2 RIGHTS-OF-WAY.

3 (b) REPRESENTS THE COMMERCIAL TIMBER INDUSTRY.

4 (c) REPRESENTS THE MINERAL OR ENERGY DEVELOPMENT INDUSTRY.

5 10. ONE PERSON WHO IS APPOINTED BY THE SPEAKER OF THE HOUSE OF
6 REPRESENTATIVES AND WHO EITHER:

7 (a) REPRESENTS DISPERSED RECREATIONAL ACTIVITY INTERESTS.

8 (b) REPRESENTS ARCHAEOLOGICAL OR HISTORICAL INTERESTS.

9 (c) REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED WILD HORSE AND
10 BURRO INTEREST GROUP.

11 11. ONE PERSON WHO REPRESENTS A NATIONALLY OR REGIONALLY RECOGNIZED
12 ENVIRONMENTAL OR CONSERVATION ORGANIZATION AND WHO IS APPOINTED BY THE
13 SPEAKER OF THE HOUSE OF REPRESENTATIVES.

14 12. ONE PERSON WHO REPRESENTS INDIAN TRIBES IN THIS STATE AND WHO IS
15 APPOINTED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.

16 13. A PUBLIC MEMBER WHO IS APPOINTED BY THE SPEAKER OF THE HOUSE OF
17 REPRESENTATIVES.

18 B. THE COUNCIL SHALL ELECT A CHAIRPERSON AND VICE-CHAIRPERSON FROM
19 AMONG ITS MEMBERS. THE COUNCIL SHALL ELECT A NEW CHAIRPERSON AND
20 VICE-CHAIRPERSON EACH CALENDAR YEAR.

21 C. THE INITIAL COUNCIL MEMBERS SHALL ASSIGN THEMSELVES BY LOT TO TERMS
22 OF ONE, TWO AND THREE YEARS IN OFFICE. ALL SUBSEQUENT MEMBERS SERVE
23 THREE-YEAR TERMS. THE CHAIRPERSON SHALL NOTIFY THE APPOINTING AUTHORITY ON
24 APPOINTMENT OF THESE TERMS.

25 D. COUNCIL MEMBERS ARE NOT ELIGIBLE TO RECEIVE COMPENSATION BUT ARE
26 ELIGIBLE FOR REIMBURSEMENT OF EXPENSES PURSUANT TO TITLE 38, CHAPTER 4,
27 ARTICLE 2.

28 E. A COUNCIL MEMBER SHALL NOT PARTICIPATE IN ANY SPECIFIC MATTER,
29 INCLUDING A LEASE, LICENSE, PERMIT, CONTRACT, CLAIM, AGREEMENT OR RELATED
30 LITIGATION WITH THE UNITED STATES BUREAU OF LAND MANAGEMENT, IN WHICH THE
31 MEMBER HAS A DIRECT FINANCIAL INTEREST.

32 F. THE CHAIRPERSON OF THE COUNCIL MAY FORM SUBCOMMITTEES FOR THE
33 PURPOSE OF COMPILING INFORMATION OR CONDUCTING RESEARCH. A SUBCOMMITTEE
34 SHALL REPORT ITS RECOMMENDATIONS TO THE FULL COUNCIL FOR CONSIDERATION.

35 G. THE COUNCIL SHALL:

36 1. ACT AS AN ADVISORY BODY REGARDING THE PLANNING AND MANAGEMENT OF
37 FEDERAL LAND RESOURCES IN THIS STATE EXCEPT FOR RANGELAND RESOURCES.

38 2. DEVELOP RECOMMENDATIONS FOR:

39 (a) THE UNITED STATES BUREAU OF LAND MANAGEMENT AND ANY OTHER FEDERAL
40 LAND MANAGEMENT AGENCY, AS DETERMINED BY THE COUNCIL, REGARDING LAND USE
41 PLANNING, CLASSIFICATION AND RETENTION AND THE MANAGEMENT AND DISPOSAL OF
42 FEDERAL LANDS WITHIN THIS STATE EXCEPT FOR RANGELAND RESOURCES.

43 (b) ANY OTHER MATTER ON REQUEST OF THE GOVERNOR, PRESIDENT OF THE
44 SENATE, SPEAKER OF THE HOUSE OF REPRESENTATIVES OR STATE LAND COMMISSIONER.
