AN ACT

AMENDING TITLE 41, CHAPTER 3, ARTICLE 1.1, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-511.17; AMENDING TITLE 43, CHAPTER 6, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 43-622; RELATING TO THE ARIZONA STATE PARKS BOARD.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 3, article 1.1, Arizona Revised Statutes,
3 is amended by adding section 41-511.17, to read:

4 41-511.17. Sustainable state parks and roads fund

5 THE SUSTAINABLE STATE PARKS AND ROADS FUND IS ESTABLISHED CONSISTING OF
6 MONIES RECEIVED PURSUANT TO SECTION 43-622. THE ARIZONA STATE PARKS BOARD
7 SHALL ADMINISTER THE FUND. MONIES IN THE FUND ARE CONTINUOUSLY APPROPRIATED.
8 THE ARIZONA STATE PARKS BOARD SHALL USE THE MONIES IN THE FUND TO OPERATE,
9 MAINTAIN AND MAKE CAPITAL IMPROVEMENTS TO BUILDINGS, ROADS, PARKING LOTS,
10 HIGHWAY ENTRANCES AND ANY RELATED STRUCTURE USED TO OPERATE STATE PARKS.

11 Sec. 2. Title 43, chapter 6, article 1, Arizona Revised Statutes, is
12 amended by adding section 43-622, to read:

13 43-622. Contribution to sustainable state parks and roads fund

14 A. THE DEPARTMENT SHALL PROVIDE A SPACE ON THE INDIVIDUAL INCOME TAX
15 RETURN FORM IN WHICH A TAXPAYER MAY DESIGNATE AN AMOUNT OF THE TAXPAYER'S
16 REFUND AS A VOLUNTARY CONTRIBUTION TO THE SUSTAINABLE STATE PARKS AND ROADS
17 FUND ESTABLISHED BY SECTION 41-511.17.

18 B. AFTER SUBTRACTING ANY SETOFF FOR DEBTS PURSUANT TO SECTION 42-1122,
19 THE DEPARTMENT SHALL SUBTRACT THE DESIGNATED AMOUNT FROM THE REFUND DUE THE
20 TAXPAYER AND TRANSFER IT TO THE ARIZONA STATE PARKS BOARD FOR DEPOSIT IN THE
21 SUSTAINABLE STATE PARKS AND ROADS FUND.

22 C. THE TAXPAYER MAY ALSO DONATE ANY AMOUNT TO THE SUSTAINABLE STATE
23 PARKS AND ROADS FUND, IN LIEU OF OR IN ADDITION TO THE DESIGNATED PORTION OF
24 THE TAX REFUND, BY AN APPROPRIATE INDICATION ON THE RETURN AND BY INCLUDING
25 THAT AMOUNT WITH THE RETURN.
