## **HOUSE BILL 2378**

AN ACT

AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-499.17; RELATING TO MUNICIPAL TAXATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes, is  
3 amended by adding section 9-499.17, to read:

4 9-499.17. Prohibition on municipal taxes and fees

5 EXCEPT FOR A MUNICIPALITY THAT HAS, BEFORE DECEMBER 31, 2013, ADOPTED  
6 AN ORDINANCE REQUIRING PROPERTY OWNERS TO OBTAIN FIRE PREVENTION AND CONTROL  
7 SERVICES AND EXCEPT AS PROVIDED IN THIS TITLE AND TITLES 35 AND 42, A  
8 MUNICIPALITY MAY NOT LEVY OR ASSESS A MUNICIPALITY-WIDE TAX OR FEE AGAINST  
9 PROPERTY OWNERS BASED ON THE SIZE OR VALUE OF THE OWNER'S REAL PROPERTY OR  
10 IMPROVEMENTS TO REAL PROPERTY FOR ANY PUBLIC SERVICE PROVIDED BY THE  
11 MUNICIPALITY.

12 Sec. 2. Retroactivity

13 This act is effective retroactively to from and after December 31,  
14 2013.


