## **HOUSE BILL 2135**

AN ACT

REPEALING SECTION 41-3014.14, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3022.14; RELATING TO THE MILITARY AFFAIRS COMMISSION.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Repeal  
3 Section 41-3014.14, Arizona Revised Statutes, is repealed.  
4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is  
5 amended by adding section 41-3022.14, to read:  
6 41-3022.14. Military affairs commission; termination July 1,  
7 2022  
8 A. THE MILITARY AFFAIRS COMMISSION TERMINATES ON JULY 1, 2022.  
9 B. SECTION 26-261 IS REPEALED ON JANUARY 1, 2023.  
10 Sec. 3. Purpose  
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,  
12 the legislature continues the military affairs commission to monitor military  
13 issues in this state, including matters affecting the military installations  
14 in this state.  
15 Sec. 4. Retroactivity  
16 Sections 1 and 2 of this act are effective retroactively to July 1,  
17 2014.




