## **SENATE BILL 1108**

AN ACT

AMENDING TITLE 3, CHAPTER 2, ARTICLE 5, ARIZONA REVISED STATUTES, BY ADDING SECTION 3-351.01; PROVIDING FOR THE DELAYED REPEAL OF SECTION 3-351.01, ARIZONA REVISED STATUTES, AS ADDED BY THIS ACT; RELATING TO THE ARIZONA DEPARTMENT OF AGRICULTURE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 3, chapter 2, article 5, Arizona Revised Statutes, is  
3 amended by adding section 3-351.01, to read:

4 3-351.01. Registration fee; increase or decrease; exemption

5 A. NOTWITHSTANDING ANY OTHER LAW, THE DIRECTOR, WITH THE ASSISTANCE OF  
6 THE DEPARTMENT OF AGRICULTURE ADVISORY COUNCIL, MAY INCREASE OR DECREASE THE  
7 REGISTRATION FEE ESTABLISHED BY SECTION 3-351 UNTIL JUNE 30, 2016.

8 B. ANY ADDITIONAL REVENUE GENERATED BY INCREASING THE FEE AS PROVIDED  
9 IN SUBSECTION A OF THIS SECTION MUST BE DEPOSITED IN THE PESTICIDE TRUST FUND  
10 ESTABLISHED BY SECTION 3-350. THE FEE MAY NOT BE REDUCED PURSUANT TO  
11 SUBSECTION A OF THIS SECTION BELOW ONE HUNDRED DOLLARS.

12 C. THE DEPARTMENT IS EXEMPT FROM THE RULEMAKING REQUIREMENTS OF TITLE  
13 41, CHAPTER 6 FOR THE PURPOSE OF INCREASING OR DECREASING FEES PURSUANT TO  
14 THIS SECTION UNTIL JULY 1, 2016.

15 Sec. 2. Delayed repeal

16 Section 3-351.01, Arizona Revised Statutes, as added by this act, is  
17 repealed from and after June 30, 2016.
