HOUSE BILL 2272

AN ACT

AMENDING TITLE 38, CHAPTER 8, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 38-1115; RELATING TO LAW ENFORCEMENT OFFICERS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 38, chapter 8, article 1, Arizona Revised Statutes,
3 is amended by adding section 38-1115, to read:
4 38-1115. Officers; purchase of firearm; definitions
5 A. ON RETIREMENT, AN OFFICER WHO IS A MEMBER OF AN ELIGIBLE RETIREMENT
6 SYSTEM, SUBJECT TO THE OFFICER'S EMPLOYER'S APPROVAL, MAY PURCHASE THE
7 FIREARMS ISSUED BY THE EMPLOYER TO THE OFFICER AT A PRICE DETERMINED BY THE
8 ADMINISTRATOR OF THE AGENCY EMPLOYING THE LAW ENFORCEMENT OFFICER. THIS
9 SUBSECTION APPLIES TO AN OFFICER WHO IS A MEMBER OF AN ELIGIBLE RETIREMENT
10 SYSTEM AND TO WHOM A FIREARM IS ISSUED DURING THE COURSE OF THE OFFICER'S
11 EMPLOYMENT BY AN EMPLOYER AS DEFINED IN SECTION 38-711, 38-801, 38-842 OR
12 38-881.
13 B. FOR THE PURPOSES OF THIS SECTION:
14 1. "ELIGIBLE RETIREMENT SYSTEM" MEANS THE ARIZONA STATE RETIREMENT
15 SYSTEM, THE ELECTED OFFICIALS' RETIREMENT PLAN, THE PUBLIC SAFETY PERSONNEL
16 RETIREMENT SYSTEM AND THE CORRECTIONS OFFICER RETIREMENT PLAN.
17 2. "FIREARMS" MEANS ANY HANDGUNS, PISTOLS, REVOLVERS, RIFLES, SHOTGUNS
18 OR OTHER WEAPONS THAT ARE DESIGNED TO, WILL OR MAY BE READILY CONVERTED TO
19 EXPEL A PROJECTILE BY THE ACTION OF EXPANDING GASES.
20 3. "OFFICER" MEANS A LAW ENFORCEMENT OFFICER AS DEFINED IN SECTION
21 38-1101 OR A PROBATION OFFICER AS DEFINED IN SECTION 38-1131.
