# **SENATE BILL 1300**

AN ACT

ESTABLISHING A LAW ENFORCEMENT OFFICER BODY CAMERA STUDY COMMITTEE.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Law enforcement officer body camera study committee;  
3 membership; duties; report; delayed repeal

4 A. The law enforcement officer body camera study committee is  
5 established consisting of the following members:

6 1. One member of the senate who is appointed by the president of the  
7 senate and who serves as cochairperson of the committee.

8 2. One member of the house of representatives who is appointed by the  
9 speaker of the house of representatives and who serves as cochairperson of  
10 the committee.

11 3. The director of the department of public safety or the director's  
12 designee.

13 4. One police chief of a police department in this state who is  
14 appointed by the governor.

15 5. One county sheriff who is appointed by the governor.

16 6. One member who is a faculty member in a criminal justice program at  
17 a university in this state and who is appointed by the governor.

18 7. One representative of a news gathering organization who is  
19 appointed by the governor.

20 8. One member who is a state prosecutor and who is appointed by the  
21 Arizona prosecuting attorneys' advisory council.

22 9. Three persons who are members of a police association and who are  
23 appointed by the governor.

24 10. Two attorneys who are members of the state bar, one of whom  
25 represents a group that promotes civil liberties, and who are appointed by  
26 the governor.

27 11. Two public members who are residents of this state, one of whom is  
28 associated with a civil rights association, and who are appointed by the  
29 governor.

30 B. The study committee shall recommend policies and laws on the use of  
31 law enforcement officer body cameras and body camera recordings.

32 C. The law enforcement officer body camera study committee may:

33 1. Request information, data and reports from any county or state  
34 agency or political subdivision of this state. If possible, information  
35 shall be provided electronically.

36 2. Hold hearings, conduct fact-finding tours and take testimony from  
37 witnesses, including participants in the criminal justice system, who may  
38 assist the committee in fulfilling its responsibilities.

39 D. On the request of the law enforcement officer body camera study  
40 committee, an agency of this state shall provide to the committee its  
41 services, equipment, documents, personnel and facilities to the extent  
42 possible without cost to the committee.

43 E. The legislature shall provide staff and support services to the  
44 committee.

1 F. The committee shall meet at the state capitol or at other places as  
2 the cochairpersons deem necessary or convenient, and all meetings shall be  
3 open to the public.

4 G. Members of the study committee are not eligible to receive  
5 compensation but are eligible for reimbursement of expenses pursuant to title  
6 38, chapter 4, article 2, Arizona Revised Statutes.

7 H. On or before December 31, 2015, the study committee shall submit a  
8 report regarding its findings and recommendations to the governor, the  
9 speaker of the house of representatives and the president of the senate and  
10 provide a copy of its report to the secretary of state. The report shall  
11 include the committee's recommendations regarding the use of law enforcement  
12 officer body cameras in this state.

13 I. This section is repealed from and after June 30, 2016.
