## **SENATE BILL 1440**

AN ACT

AMENDING TITLE 36, CHAPTER 29, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-2960; MAKING APPROPRIATIONS; RELATING TO THE ARIZONA LONG-TERM CARE SYSTEM.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 29, article 2, Arizona Revised Statutes,  
3 is amended by adding section 36-2960, to read:

4 36-2960. Persons with developmental disabilities;  
5 cost-effective study rate; report

6 THE DEPARTMENT SHALL ANNUALLY DETERMINE THE COST-EFFECTIVE STUDY RATE  
7 FOR PERSONS RECEIVING DEVELOPMENTAL DISABILITY SERVICES PURSUANT TO CHAPTER  
8 5.1 OF THIS TITLE AND PROVIDE THAT RATE TO THE ARIZONA HEALTH CARE COST  
9 CONTAINMENT SYSTEM ADMINISTRATION. ON OR BEFORE JUNE 15 OF EACH YEAR, THE  
10 DEPARTMENT SHALL REPORT TO THE JOINT LEGISLATIVE BUDGET COMMITTEE THE  
11 COST-EFFECTIVE STUDY RATE FOR PERSONS RECEIVING DEVELOPMENTAL DISABILITY  
12 SERVICES THAT WAS DETERMINED FOR THE SUBSEQUENT FISCAL YEAR.

13 Sec. 2. Appropriation; department of economic security;  
14 developmental disability services

15 Notwithstanding section 23-705, Arizona Revised Statutes, the sum of  
16 \$120,000 is appropriated from the special administration fund established by  
17 section 23-705, Arizona Revised Statutes, in fiscal year 2015-2016 to the  
18 department of economic security to provide services for persons with  
19 developmental disabilities whose services were reduced under the current  
20 cost-effective study rate as a result of the fiscal year 2014-2015  
21 legislatively mandated provider rate increases.

22 Sec. 3. Appropriation; client developmental disability services  
23 trust fund; intent

24 Notwithstanding Laws 2014, second special session, chapter 2,  
25 section 7, the first \$100,000 in the long-term care system fund established  
26 by section 36-2953, Arizona Revised Statutes, that is unexpended and  
27 unencumbered at the end of fiscal year 2014-2015 is transferred to the client  
28 developmental disability services trust fund established by section 36-572,  
29 Arizona Revised Statutes, subject to approval by the Arizona health care cost  
30 containment system administration.
