2 Section 1. Section 9-802, Arizona Revised Statutes, is amended to

4 9-802. Procedure for adoption by reference
5 A municipality may enact the provisions of a code or public record
6 theretofore in existence without setting forth such THE provisions, but the
7 adopting ordinance shall be published in full. At least three PAPER copies
8 OR ONE PAPER COPY AND ONE ELECTRONIC COPY MAINTAINED IN COMPLIANCE WITH
9 SECTION 44-7041 of the code or public record shall be filed in the office of
10 the clerk of the municipality and kept available for public use and
11 inspection. A code or public record enacted by reference may be amended in
12 the same manner.




