REPEALING SECTION 41-3015.11, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3023.11; RELATING TO THE LAW ENFORCEMENT MERIT SYSTEM COUNCIL.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3015.11, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes, is
5 amended by adding section 41-3023.11, to read:

6 41-3023.11. Law enforcement merit system council; termination
7 July 1, 2023

8 A. THE LAW ENFORCEMENT MERIT SYSTEM COUNCIL TERMINATES ON JULY 1,
9 2023.

10 B. TITLE 41, CHAPTER 12, ARTICLE 10 IS REPEALED ON JANUARY 1, 2024.

11 Sec. 3. Purpose

12 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
13 the legislature continues the law enforcement merit system council to adopt
14 and enforce merit principles of public employment for the department of
15 public safety.

16 Sec. 4. Retroactivity

17 Sections 1 and 2 of this act are effective retroactively to July 1,
18 2015.
