HOUSE BILL 2288

AN ACT

AMENDING SECTION 44-1641.03, ARIZONA REVISED STATUTES; RELATING TO SCRAP
METAL DEALERS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 44-1641.03, Arizona Revised Statutes, is amended to
3 read:

4 44-1641.03. Registration; application; information disclosed on
5 website

6 A. A person must register pursuant to this article to conduct business
7 as a scrap metal dealer in this state.

8 B. A person shall submit information for registration to the
9 department in a form prescribed by the department. The information shall
10 include all of the following:

11 1. The name and address of the scrap metal dealer.

12 2. The name of each person who owns at least ten ~~per cent~~ PERCENT of a
13 scrap metal dealer business.

14 3. Full personal identification information on each owner of a scrap
15 metal dealer business including a copy of each owner's driver license.

16 4. The location of each principal office and branch office at which
17 the scrap metal dealer will conduct business in this state.

18 5. The name and address of any wholly owned subsidiary of the scrap
19 metal dealer.

20 C. A registered scrap metal dealer does not need to separately
21 register either of the following:

22 1. Any of its branch offices.

23 2. A wholly owned subsidiary of the registrant.

24 D. THE DEPARTMENT MUST POST THE INFORMATION THAT IS SUBMITTED PURSUANT
25 TO SUBSECTION B, PARAGRAPHS 1 AND 4 OF THIS SECTION ON THE DEPARTMENT'S
26 WEBSITE.
