# **SENATE BILL 1246**

AN ACT

AMENDING SECTION 42-3106, ARIZONA REVISED STATUTES; APPROPRIATING MONIES;  
RELATING TO THE STATE DEPARTMENT OF CORRECTIONS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 42-3106, Arizona Revised Statutes, is amended to  
3 read:

4 42-3106. Monies allocated to the drug treatment and education  
5 fund; state department of corrections revolving fund

6 A. Notwithstanding any law to the contrary, seven ~~per cent~~ PERCENT of  
7 the monies collected pursuant to section 42-3052, paragraph 1 and eighteen  
8 ~~per cent~~ PERCENT of the monies collected pursuant to section 42-3052,  
9 paragraphs 2, 3 and 4 shall be deposited in the drug treatment and education  
10 fund established by section 13-901.02.

11 B. Notwithstanding any law to the contrary, three ~~per cent~~ PERCENT of  
12 the monies collected pursuant to section 42-3052, paragraph 1 and seven ~~per~~  
13 ~~cent~~ PERCENT of the monies collected pursuant to section 42-3052, paragraphs  
14 2, 3 and 4 shall be deposited in a separate revolving fund of the state  
15 department of corrections.

16 C. Monies in the separate revolving fund of the state department of  
17 corrections shall be used for the following purposes:

18 1. Implementing section 31-411.01.

19 2. Offender participation in appropriate drug treatment ~~or education~~  
20 programs that are administered BY THE STATE DEPARTMENT OF CORRECTIONS OR by a  
21 qualified agency, organization or individual ~~and that are~~ IS approved OR  
22 LICENSED by the department of health services ~~for offenders who the state~~  
23 ~~department of corrections determines have a history of substance abuse and~~  
24 ~~who have been released from confinement~~ OR THE BOARD OF BEHAVIORAL HEALTH  
25 EXAMINERS.

26 3. REENTRY, EDUCATION OR MENTAL HEALTH ASSISTANCE PROGRAMS THAT ARE  
27 ADMINISTERED BY THE STATE DEPARTMENT OF CORRECTIONS OR BY A QUALIFIED AGENCY,  
28 ORGANIZATION OR INDIVIDUAL.

29 D. Monies that are deposited in the state department of corrections  
30 revolving fund pursuant to subsection B of this section shall not revert to  
31 the state general fund if unexpended at the close of the fiscal year.

32 E. If the state department of corrections receives a federal grant,  
33 any portion of the monies that are deposited pursuant to subsection B of this  
34 section may be used as a cash match.

35 Sec. 2. Appropriation; transition program

36 The sum of \$596,000 is appropriated from the transition program fund  
37 established by section 31-284, Arizona Revised Statutes, in fiscal year  
38 2016-2017 to the state department of corrections for the expansion of the  
39 transition program.


