8 A. THE DEPARTMENT OF TRANSPORTATION TERMINATES ON JULY 1, 2024.
9 B. TITLE 28 IS REPEALED ON JANUARY 1, 2025.
10 Sec. 3. Purpose
11 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
12 the legislature continues the department of transportation to:
13 1. Design, construct and maintain the state highway system and state
14 routes for the entire state.
15 2. Provide for orderly registration and titling of vehicles and
16 licensure of motor vehicle drivers.
17 3. Assist and promote the aviation industry in this state.
18 4. Provide for orderly registration and licensure of general aviation
19 aircraft.
20 Sec. 4. Retroactivity
21 Sections 1 and 2 of this act are effective retroactively to July 1,
22 2016.
