16 Sec. 3. Purpose
17 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
18 the legislature continues the public safety personnel retirement system board
19 of trustees in order to manage and invest employee and employer contributions
20 and assets and distribute retirement benefits to retired members of the
21 elected officials' retirement plan, the public safety personnel retirement
22 system and the corrections officer retirement plan.
23 Sec. 4. Retroactivity
24 Sections 1 and 2 of this act are effective retroactively to July 1,
25 2016.
