AN ACT

APPROPRIATING MONIES FOR THE RELIEF OF NAMED CLAIMANTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriations for relief of named claimants; basis
3 of claims; coordination
