AN ACT

REPEALING SECTION 28-1206, ARIZONA REVISED STATUTES; AMENDING TITLE 28, CHAPTER 3, ARTICLE 21, ARIZONA REVISED STATUTES, BY ADDING A NEW SECTION 28-1206; RELATING TO PHOTO ENFORCEMENT SYSTEMS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 28-1206, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 28, chapter 3, article 21, Arizona Revised Statutes, is
5 amended by adding a new section 28-1206, to read:

6 28-1206. Photo enforcement system; prohibited use

7 THIS STATE OR A LOCAL AUTHORITY MAY NOT USE A PHOTO ENFORCEMENT SYSTEM
8 ON A STATE HIGHWAY IN THIS STATE TO IDENTIFY VIOLATORS OF ARTICLE 3 OR 6 OF
9 THIS CHAPTER.

10 Sec. 3. Legislative intent

11 Pursuant to section 41-1107, Arizona Revised Statutes, it is the
12 legislature's intent to:

13 1. Keep the enforcement of the laws in this state in the hands of
14 trained law enforcement officers who are authorized by the people of this
15 state to enforce the laws.

16 2. Ensure that the purpose of law enforcement remains to serve and
17 protect and not to generate revenue for governments.


