13 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
14 the legislature continues the board of behavioral health examiners to
15 promote the safe and professional practice of behavioral health services.
16 Sec. 4. Retroactivity
17 Sections 1 and 2 of this act are effective retroactively to from and
18 after July 1, 2017.


