8 A. THE BOARD OF RESPIRATORY CARE EXAMINERS TERMINATES JULY 1, 2025.

11 Sec. 3. Purpose
12 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
13 the legislature continues the board of respiratory care examiners to
14 regulate the practice of respiratory care for the public health, safety
15 and welfare.
16 Sec. 4. Retroactivity
17 Sections 1 and 2 of this act are effective retroactively to from and
18 after July 1, 2017.
