**CHAPTER 259
SENATE BILL 1245**

AN ACT

PROVIDING FOR THE PLACEMENT IN WESLEY BOLIN PLAZA OF A MEMORIAL DEDICATED TO RICK LAVIS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Rick Lavis memorial; procedures; delayed repeal

3 A. Pursuant to section 41-1363, subsection A, Arizona Revised
4 Statutes, this act authorizes the department of administration to provide
5 for the placement in Wesley Bolin plaza of a memorial dedicated to Rick
6 Lavis.

7 B. The procedures prescribed in section 41-1363, Arizona Revised
8 Statutes, apply to the establishment of the memorial.

9 C. Public monies are not authorized for the costs of the memorial.
10 All fund-raising and contracts for artistic design and construction of the
11 memorial are the sole responsibility of the proponents. This state may
12 not facilitate fund-raising or establish a state fund for the deposit of
13 the monies.

14 D. This section is repealed from and after September 30, 2020.
