AN ACT

AMENDING SECTION 30-108, ARIZONA REVISED STATUTES; RELATING TO THE ARIZONA
POWER AUTHORITY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 30-108, Arizona Revised Statutes, is amended to
3 read:

4 30-108. Powers and duties of commission; annual report

5 A. The members of the commission shall devote to their duties as
6 members such time and attention as is necessary to effectuate the purposes
7 of this chapter and to carry out their duties and exercise their powers.
8 The commission shall designate a person or persons who shall execute all
9 documents and instruments on behalf of the authority.

10 B. The commission shall acquire suitable offices, furnishings and
11 articles of equipment and necessary supplies.

12 C. Subject to title 41, chapter 4, article 4, the commission may
13 employ a person in the capacity of director, manager or chief engineer who
14 shall be a duly licensed engineer, but who need not be a resident or
15 licensed in this state. ~~Such~~ THE person shall be actively engaged in the
16 practice of ~~his~~ THE PERSON'S profession and trained and experienced in the
17 performance of ~~his~~ THE PERSON'S duties. ~~Such~~ THE person shall not hold
18 any other public office or have any interest in a business that may be
19 adversely affected by the operation of the authority in the exercise of
20 ~~its~~ THE AUTHORITY'S powers and discharge of ~~its~~ THE AUTHORITY'S duties.

21 D. The commission shall make and submit to the governor, THE
22 PRESIDENT OF THE SENATE, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE
23 CHAIRMAN OF THE SENATE NATURAL RESOURCES, ENERGY AND WATER COMMITTEE AND
24 THE CHAIRMAN OF THE HOUSE OF REPRESENTATIVES ENERGY, ENVIRONMENT AND
25 NATURAL RESOURCES COMMITTEE, OR THEIR SUCCESSOR COMMITTEES, on or before
26 December 1 each year a report containing a full and complete account of
27 ~~its~~ THE COMMISSION'S transactions and proceedings for the preceding fiscal
28 year, together with other facts, suggestions and recommendations deemed of
29 public value.






