AMENDING SECTIONS 20-1376.09 AND 20-1406.09, ARIZONA REVISED STATUTES;
RELATING TO DISABILITY INSURANCE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 20-1376.09, Arizona Revised Statutes, is amended
3 to read:

4 20-1376.09. Coverage of health care services

5 All policies issued, delivered or renewed on or after July 1, 2017
6 by a disability insurer in this state must provide coverage for lawful
7 health care services that are provided by a health care provider to an
8 insured regardless of the familial relationship of the health care
9 provider to the insured if the health care service would be covered were
10 it provided to an insured who was not related to the health care provider.
11 The policy may limit the coverage to those health care providers who are
12 members of the disability insurer's provider network. THIS SECTION DOES
13 NOT APPLY TO DISABILITY INCOME.

14 Sec. 2. Section 20-1406.09, Arizona Revised Statutes, is amended to

16 20-1406.09. Coverage of health care services

17 All policies issued, delivered or renewed on or after July 1, 2017
18 by a group or blanket disability insurer in this state must provide
19 coverage for lawful health care services that are provided by a health
20 care provider to an insured regardless of the familial relationship of the
21 health care provider to the insured if the health care service would be
22 covered were it provided to an insured who was not related to the health
23 care provider. The policy may limit the coverage to those health care
24 providers who are members of the insurer's provider network. THIS SECTION
25 DOES NOT APPLY TO DISABILITY INCOME.
