**CHAPTER 33**  
**HOUSE BILL 2211**

AN ACT

AMENDING TITLE 41, CHAPTER 11, ARTICLE 1, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 41-1604.14; RELATING TO THE DEPARTMENT OF CORRECTIONS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 11, article 1, Arizona Revised  
3 Statutes, is amended by adding section 41-1604.14, to read:

4 41-1604.14. Drug and alcohol treatment programs; annual  
5 report

6 A. ON OR BEFORE DECEMBER 1 EACH YEAR, THE DIRECTOR SHALL REPORT ON  
7 THE DRUG AND ALCOHOL TREATMENT PROGRAMS AVAILABLE TO OFFENDERS IN THIS  
8 STATE WHO ARE UNDER THE JURISDICTION OF THE DEPARTMENT. THE REPORT SHALL  
9 INCLUDE:

10 1. A DESCRIPTION OF EACH PROGRAM, INCLUDING WHETHER THE PROGRAM IS  
11 FOR OFFENDERS WHO ARE IMPRISONED OR FOR OFFENDERS WHO ARE ON COMMUNITY  
12 SUPERVISION OR PAROLE.

13 2. THE NUMBER OF OFFENDERS WHO ARE CURRENTLY RECEIVING SERVICES  
14 FROM A PROGRAM AND THE TOTAL NUMBER OF OFFENDERS WHO RECEIVED SERVICES  
15 OVER THE PREVIOUS TWELVE MONTHS.

16 3. THE COST PER OFFENDER FOR EACH PROGRAM AND THE SOURCE OF THE  
17 MONIES THAT ARE USED.

18 4. THE NAME OF EACH DRUG AND ALCOHOL TREATMENT PROGRAM PROVIDER.

19 5. A COMPARISON OF THE DRUG AND ALCOHOL TREATMENT PROGRAMS THAT ARE  
20 OFFERED TO:

21 (a) OFFENDERS WHO ARE IN A DEPARTMENT FACILITY.

22 (b) OFFENDERS WHO ARE IN A PRIVATE PRISON THAT CONTRACTS WITH THE  
23 DEPARTMENT.

24 (c) OFFENDERS WHO ARE ON COMMUNITY SUPERVISION OR PAROLE.

25 B. THE REPORT SHALL BE SUBMITTED TO THE GOVERNOR, THE PRESIDENT OF  
26 THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND A COPY OF  
27 THIS REPORT SHALL BE PROVIDED TO THE SECRETARY OF STATE.




