AMENDING SECTIONS 48-1041 AND 48-1044, ARIZONA REVISED STATUTES; RELATING
TO RURAL ROAD IMPROVEMENT DISTRICTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 48-1041, Arizona Revised Statutes, is amended to

4 48-1041. Participation by county

5 The board of supervisors, by resolution, may summarily order that
6 the county pay part of the costs of any rural road improvement, INCLUDING
7 PRELIMINARY INCIDENTAL COSTS.

8 Sec. 2. Section 48-1044, Arizona Revised Statutes, is amended to
9 read:

10 48-1044. Finances

11 The rural road improvement projects may be financed from the
12 following sources of revenue:

13 1. Proceeds received from the sale of bonds of the district. IN
14 ADDITION TO ISSUING GENERAL OBLIGATION BONDS AS PRESCRIBED BY SECTION
15 48-1045, THE DISTRICT MAY ISSUE IMPROVEMENT BONDS IN THE MANNER PRESCRIBED
16 FOR COUNTY IMPROVEMENT DISTRICTS ESTABLISHED PURSUANT TO ARTICLE 1 OF THIS
17 CHAPTER THAT ARE PAYABLE OVER NOT MORE THAN TEN YEARS.

18 2. Monies of the county ~~which~~ THAT are contributed to the district.

19 3. State or federal grants.

20 4. Private contributions.

21 5. Any other monies available to the district by law.
