**HOUSE BILL 2536**

AN ACT

PROVIDING FOR THE APPOINTMENT OF THE OMBUDSMAN-CITIZENS AIDE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appointment of ombudsman-citizens aide

3 Pursuant to section 41-1373, subsection B, Arizona Revised Statutes,  
4 Dennis Wells is appointed ombudsman-citizens aide for a term ending from  
5 and after June 30, 2022, subject to the terms and conditions prescribed by  
6 law.

7 Sec. 2. Requirements for appointment

8 Pursuant to section 41-1373, subsection B, Arizona Revised Statutes,  
9 this act requires approval of the appointment by roll call vote of at  
10 least two-thirds of the membership of each house of the legislature and  
11 the approval of the governor or, if the governor vetoes this act, this act  
12 requires the subsequent approval of the appointment by roll call vote of  
13 at least three-fourths of the membership of each house of the legislature.

14 Sec. 3. Emergency

15 This act is an emergency measure that is necessary to preserve the  
16 public peace, health or safety and is operative immediately as provided by  
17 law.
