AN ACT

REPEALING SECTION 41-3017.07, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-3025.01; RELATING TO THE ARIZONA CRIMINAL JUSTICE COMMISSION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Section 41-3017.07, Arizona Revised Statutes, is repealed.

4 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes,
5 is amended by adding section 41-3025.01, to read:

6 41-3025.01. Arizona criminal justice commission; termination
7 July 1, 2025

8 A. THE ARIZONA CRIMINAL JUSTICE COMMISSION TERMINATES ON JULY
9 1, 2025.

10 B. SECTIONS 41-2404 AND 41-2405 AND THIS SECTION ARE REPEALED ON
11 JANUARY 1, 2026.

12 Sec. 3. Purpose

13 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
14 the legislature continues the Arizona criminal justice commission to
15 provide a cooperative exchange of information and analysis of issues
16 relating to criminal justice and law enforcement among different public
17 and private agencies.

18 Sec. 4. Retroactivity

19 Sections 1 and 2 of this act are effective retroactively to July
20 1, 2017.
