SENATE BILL 1117

AN ACT

AMENDING LAWS 2015, CHAPTER 42, SECTION 1; RELATING TO THE FALLEN
CORRECTIONAL EMPLOYEES MEMORIAL.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Laws 2015, chapter 42, section 1 is amended to read:

3 Section 1. Fallen correctional employees memorial;
4 procedures; delayed repeal

5 A. Pursuant to section 41-1363, subsection A, Arizona Revised
6 Statutes, this act authorizes the department of administration to provide
7 for the placement of a memorial dedicated to the commemoration of fallen
8 state department of corrections employees in an area with a western
9 boundary of seventeenth avenue, a northern boundary of Jefferson street,
10 an eastern boundary of sixteenth avenue and a southern boundary of Madison
11 street.

12 B. The procedures prescribed in section 41-1363, subsection B,
13 Arizona Revised Statutes, apply to the establishment of the memorial,
14 EXCEPT THAT THE MEMORIAL SHALL BE COMPLETED AND DEDICATED TO THIS STATE ON
15 OR BEFORE SEPTEMBER 30, 2020.

16 C. Public monies are not authorized for the costs of the memorial.
17 All fund-raising and contracts for artistic design and construction of the
18 memorial are the sole responsibility of the proponents. This state may
19 not facilitate fund-raising or establish a state fund for the deposit of
20 the monies.

21 D. This section is repealed from and after September 30, ~~2018~~ 2020.
