# SENATE BILL 1058

AN ACT

APPROPRIATING MONIES TO THE SECRETARY OF STATE.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Secretary of state; supplemental appropriation;  
3 congressional district special primary and  
4 special general elections; report; fiscal year  
5 2017-2018; exemption

6 A. In addition to any other appropriations made in fiscal year  
7 2017-2018, the sum of \$2,500,000 is appropriated from the state general  
8 fund in fiscal year 2017-2018 to the secretary of state for the purpose of  
9 reimbursing expenses incurred by a county for the administration of the  
10 special primary and special general elections to fill the vacancy in the  
11 United States house of representatives for Arizona's congressional  
12 district 8.

13 B. The secretary of state shall reimburse a county for the  
14 additional cost of printing ballots and other election materials,  
15 compensation paid to election board and tally board officers serving  
16 during the special elections, as well as other costs of administering the  
17 special elections. The secretary of state may advance a portion of the  
18 estimated expenses to the county. A county that receives an advance shall  
19 provide subsequent documentation to the secretary of state pursuant to  
20 subsection C of this section.

21 C. The clerk of the board of supervisors shall submit to the  
22 secretary of state for approval itemized claims, together with  
23 documentation, verified by the clerk, for expenses incurred or to be  
24 incurred by the county as prescribed by subsection B of this section. The  
25 clerk of the board of supervisors shall submit the verified claims to the  
26 secretary of state on or before June 30, 2018.

27 D. On approval of a claim by the secretary of state, the secretary  
28 of state shall submit the claim to the department of administration for  
29 payment to the county from the monies appropriated in subsection A of this  
30 section.

31 E. On or before October 1, 2018, the secretary of state shall  
32 submit a report to the joint legislative budget committee and the  
33 governor's office of strategic planning and budgeting regarding  
34 reimbursements made pursuant to this section.

35 F. The appropriation made in subsection A of this section is exempt  
36 from the provisions of section 35-190, Arizona Revised Statutes, relating  
37 to lapsing of appropriations, except that all monies remaining unexpended  
38 and unencumbered on December 31, 2018 revert to the state general fund.
