CHAPTER 174

HOUSE BILL 2042

AN ACT

AMENDING SECTIONS 20-841.09, 20-1057.13, 20-1376.05 AND 20-1406.05,
ARIZONA REVISED STATUTES; RELATING TO TELEMEDICINE.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 20-841.09, Arizona Revised Statutes, is amended
3 to read:

4 20-841.09. Telemedicine: coverage of health care services:
5 definitions

6 A. All contracts issued, delivered or renewed on or after
7 January 1, 2018 must provide coverage for health care services that are
8 provided through telemedicine if the health care service would be covered
9 were it provided through in-person consultation between the subscriber and
10 a health care provider and provided to a subscriber receiving the service
11 in this state. The contract may limit the coverage to those health care
12 providers who are members of the corporation's provider network.

13 B. This section does not prevent a corporation from imposing
14 deductibles, copayment or coinsurance requirements for a health care
15 service provided through telemedicine if the deductible, copayment or
16 coinsurance does not exceed the deductible, copayment or coinsurance
17 applicable to an in-person consultation for the same health care service.

18 C. Services provided through telemedicine or resulting from a
19 telemedicine consultation shall comply with Arizona licensure
20 requirements, accreditation standards and any practice guidelines of a
21 national association of medical professionals promoting access to medical
22 care for consumers via telecommunications technology or other qualified
23 medical professional societies to ensure quality of care.

24 D. This section does not apply to limited benefit coverage as
25 defined in section 20-1137.

17 deductibles, copayment or coinsurance requirements for a health care
18 service provided through telemedicine if the deductible, copayment or
19 coinsurance does not exceed the deductible, copayment or coinsurance
20 applicable to an in-person consultation for the same health care service.

21 C. Services provided through telemedicine or resulting from a
22 telemedicine consultation shall comply with Arizona licensure

11 telemedicine if the health care service would be covered were it provided
12 through in-person consultation between the insured and a health care
13 provider and provided to an insured receiving the service in this state.
14 The policy may limit the coverage to those health care providers who are
15 members of the insurer's provider network.

16 B. This section does not prevent a group or blanket disability
17 insurer from imposing deductibles, copayment or coinsurance requirements
18 for a health care service provided through telemedicine if the deductible,
19 copayment or coinsurance does not exceed the deductible, copayment or
20 coinsurance applicable to an in-person consultation for the same health
21 care service.

22 C. Services provided through telemedicine or resulting from a
23 telemedicine consultation shall comply with Arizona licensure
24 requirements, accreditation standards and any practice guidelines of a
25 national association of medical professionals promoting access to medical
26 care for consumers via telecommunications technology or other qualified
27 medical professional societies to ensure quality of care.


