**HOUSE BILL 2022**

AN ACT

APPROPRIATING MONIES TO THE ARIZONA STATE SCHOOLS FOR THE DEAF AND THE  
BLIND.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriation; Arizona state schools for the deaf  
3 and the blind; early childhood and family  
4 education program

5 In addition to any other appropriations made in fiscal year  
6 2018-2019, the sum of \$2,070,000 and 21 FTE positions are appropriated  
7 from the telecommunication fund for the deaf in fiscal year 2018-2019 to  
8 the Arizona state schools for the deaf and the blind for an early  
9 childhood and family education program.






