CHAPTER 43

HOUSE BILL 2060

AN ACT

AMENDING TITLE 27, CHAPTER 6, ARTICLE 2, ARIZONA REVISED STATUTES, BY
ADDING SECTION 27-1237; RELATING TO AGGREGATE MINED LAND RECLAMATION.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 27, chapter 6, article 2, Arizona Revised
3 Statutes, is amended by adding section 27-1237, to read:
4 27-1237. Variances
5 THE INSPECTOR, BY RULE OR CONDITIONAL ORDER, MAY ALLOW AN OWNER OR
6 OPERATOR OF AN EXPLORATION OPERATION OR AGGREGATE MINING UNIT TO VARY FROM
7 ANY RULE ADOPTED PURSUANT TO THIS CHAPTER OR ANY REQUIREMENT OR CONDITION
8 OF A RECLAMATION PLAN ISSUED PURSUANT TO THIS CHAPTER IF THE INSPECTOR
9 FINDS THAT ALLOWING THE VARIANCE WILL NOT ENDANGER PUBLIC SAFETY AND WILL
10 NOT BE INCONSISTENT WITH THE OBJECTIVES OF THE RECLAMATION PLAN.
