AN ACT

APPROPRIATING MONIES TO THE DEPARTMENT OF ADMINISTRATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriation; department of administration;  
3 retirement of lease-purchase agreements

4 The sum of \$190,000,000 is appropriated from the state general fund  
5 in fiscal year 2019-2020 to the department of administration to retire the  
6 lease-purchase agreements entered into pursuant to Laws 2010, sixth  
7 special session, chapter 4, section 2.
