Re: Hand Count Results, Primary Election July 30, 2024

Pursuant to A.R.S. §16-602(B), Navajo County conducted a Hand Count for the July 30, 2024, Primary Election.

On Monday, July 15th at 1:00 pm, representatives from the Navajo County Democratic and Republican Parties met to select and the early ballot batches for the hand count.

Conducting the Hand Count

The Hand Count teams met on July 31st at 1:00 pm to draw the vote centers and races, we then reconvened on Saturday, Aug. 3, 2024, 2024. There were 6 boards made up 3 members: 9 Democrats and 9 Republican. The stacking method was used for counting.

The two polling locations selected for the hand count were:

- Show Low Gym – Central Count (724 ballots)
- Sun Valley – Central Count (26 ballots)

Both Vote Center ballots were tabulated on the DS850 Central Count machine; the hand count therefore provides information on the tabulation accuracy of each machine. For each machine, the hand count results matched the tabulated results.

Under Arizona law, the hand count of early ballots needed to include 1% of early ballots cast in Navajo County. With an estimated 20,000 early ballots counted prior to the hand count. The actual count was 10,899 = 109, the Hand Count Board counted two batches of ballots: each batch contained 100 ballots. In total, 200 early ballots were counted in the hand count. The results of each hand count matched the tabulated results; there were no discrepancies. The results for each hand count are shown here:
