2024 Presidential Preference Election Canvass Results

- ◆ On Tuesday, February 20, 2024, the Secretary of State's Election Officials performed the Logic and Accuracy Test with 100% accuracy
- ◆ Vote-By-Mail Early Voting
 - Vote-by-mail packages were mailed out to eligible Active Early Voting List (AEVL) voters 27 days before Election Day on February 21, 2024
 - Nineteen (19) official drop boxes located throughout the county were utilized



2024 Presidential Preference Election Canvass Results

◆ In-Person Early Voting

- Began on Wednesday, February 21, 2024, and ended on Friday, March 15, 2024
- Three (3) locations
 - Yavapai County Administration Bldg – Prescott
 - Prescott Valley Town - Annex Building
 - Yavapai County Administration Bldg - Cottonwood



2024 Presidential Preference Election Canvass Results

- ◆ Election Day Voting – Vote Centers
 - Twenty-seven (27) Vote Centers were utilized throughout Yavapai County on Election Day
 - Vote Centers open 6 am to 7 pm
 - Initial results were uploaded just after 8 pm
 - The ballot cure period ended on Sunday, March 24, 2024, at 5pm.
 - Tabulation was completed at noon on Monday, March 25, 2024.



2024 Presidential Preference Election Canvass Results

- ◆ Statistics for the Presidential Preference Election held on March 19, 2024.
 - 117,818 eligible registered voters
 - 64, 592 ballots were counted
 - 60,521 early ballots (93.70%)
 - 4,046 vote centers ballots (6.26%)
 - 25 provisional ballots (0.04%)
 - 54.82% Yavapai County voter turnout (Gila 46.73%)
 - 39.64% voter turnout statewide
 - Yavapai County - highest voter turnout in State



2024 Presidential Preference Election Canvass Results

◆ Hand Count Audit

- Was held on Saturday, March 23, 2024
- 24 persons from the Democratic, Republican, and Libertarian Parties participated.
- 1% of all early ballots and 2 Vote Centers' ballots were randomly selected. 612 ballots in total.
- We began at 9am and concluded at 10:20am.
- The results of the Hand Count matched 100% to the machine tabulated results.



2024 Presidential Preference Election Canvass Results

- ◆ The governing body holding an election shall meet and canvass the election within 10 days following the election.
